

- Hoist #4 Project Update Staff provided an update on the timeline for completion of this additional hoist on Harford Pier.
- Extension of the Exclusive Right to Negotiate (ERN) for Red Tail Acquisitions The ERN was extended through January 24, 2017.
- Parking Plan/Costs for Harbor Terrace/Babe Lane Staff was directed to move forward on this project.
