Action from July 25, 2017 Commission Meeting -

Closed Session included 2 items:

- Real Property, Conference with Real Property Negotiators Property: Harbor Terrace.
- Real Property, Conference with Real Property Negotiators Property: Zippy's

Open Session included 13 consent items and 4 discussion items, the discussion items were as follows:

- 2017/18 Appropriation Limit: Approve Limit; Resolution 17-11 adopted.
- Harbor Update of District Policy 3026 Harbor Patrol Department and Policy Series 7000 Public Safety and Law Enforcement: Review updated policies; approved.
- Installation of Police Observation Device (POD) Camera on Avila Pier: Installation of a POD type camera on Avila Pier to provide coverage to Avila Beach; approved.
- Request from Red Tail Acquisitions to extend the Exclusive Right to Negotiate for an additional 30 days; approved.




Paddling Safety Tips – Paddling is very popular in the Port. We are happy to see everyone in the water enjoying themselves and provide these points for your added enjoyment and safety!

1. A personal flotation device (PFD) is required, it's the law.

Inflatable type PFD: Must be worn at all times, is not for children under 16, weak swimmers and non-swimmers, and where immersion is expected. May need to pull a cord or blow into a tube to inflate-see the 3 options.



Vest type PFD: Must be readily accessible to the user, must be worn at all times by children under 13 and should be worn by weak swimmers and non-swimmers. No inflation required – see the 2 options.



- 3. Don't paddle farther from shore than you can swim.
- 4. Check weather forecasts.
- 5. Avoid offshore winds and rough seas.
- 6. Paddle with a friend.
- 7. Tell a friend or family member when you plan to return.
- 8. Wear a wetsuit or other suitable clothing.
- 9. Wear a leash and hold onto your board if you get in trouble.

FAQ's BBQ's on the Beach – Am I allowed to have a BBQ on the beach? Yes, small, hand-carried gas/propane BBQs with active on/off controls may be used on any of the District's three beaches [Avila Beach, Fisherman's Beach and Olde Port Beach]. Large towable BBQs are not allowed. Wood and charcoal burning BBQs are not allowed, with the exception of the use of charcoal in the District supplied BBQs on Avila Beach.
