<p><b>Coastal Dependent Public Charitable Events-</b> events that are directly associated with fundraising for the entity which is established as a not-for profit corporation and which has been granted Federal tax-exempt status and is coastal dependent.</p> <ul style="list-style-type: none"> <li>●Staging as agreed by Harbor Manager</li> <li>●Allows for advertisement of event</li> </ul>	1-150 151-200**	\$91 \$211	Additional support costs charged as needed. Commercial enterprise associated with charitable event must apply for separate permit.
<p><b>Public Non-Charitable and Non-Coastal Dependent Events-</b> events designed for public participation which are <b>not</b> directly associated with charitable fundraising or are not coastal</p> <ul style="list-style-type: none"> <li>●Staging as agreed by Harbor Manager</li> <li>●Allows for advertisement of event</li> </ul>	less than 50 50-100 101-200**	\$702 \$912 \$1,053	Additional support costs charged as needed
<p><b>Catered or Commercially Supported Private Events-</b> events that restrict the general public's access to a site, by either physical barriers or by personnel or otherwise restrict the general public. (limited to 8 hours*)</p> <ul style="list-style-type: none"> <li>●may not take up more than 50% of space on beach between water mark and revetment</li> </ul>	less than 50 50-100 101-200**	\$702 \$912 \$1,053	allows set-up of tables, chairs, bbq grills and beach cabanas not to exceed 13' by 13'
<p><b>Wedding Ceremonies-</b> event in which two people are being married by a third person while at least one witness is in attendance. (limited to 4 hours*)</p> <ul style="list-style-type: none"> <li>●includes vow renewals</li> <li>●no amplified music allowed</li> </ul>	less than 50 50-100 101-200**	\$561 \$772 \$912	allows set-up of 1 chair per person, 1 canopy, a runner and an archway.
<p><b>Multi-Session Class/Activity-</b> a class or activity (limited to 2 hours) organized by an individual, non-profit organization, social group, or for-profit business which occurs over one to four days during a two month time period. Includes commercial activities that <u>do not</u> require any set-up or use of commercially owned equipment (e.g. fitness class with no equipment, bring your own dive equipment for dive instruction)</p> <ul style="list-style-type: none"> <li>●Allows for up to four 2-hour classes in a 60 day period</li> </ul>	less than 50  less than 50	\$91  \$211	individual, non-profit, social group, or coastal dependent  for-profit and non-coastal dependent
<p><b>Private Gatherings-</b> event that is privately organized (by a natural person), 25 or more people gathered, event is not catered, not affiliated with or enlists services of commercial enterprise, does not require support staff.</p>	25-150 151-200**	\$91 \$211	allows beach blankets, coolers, bring your own beach chairs, bring your own food.
<p><b>Public Non-Charitable Coastal Dependent</b> - event that is coastal dependent and is organized by a group, club or school (e.g. Hobi Cat races), and is not affiliated with or enlists services of commercial enterprise, does not require support staff.</p>	1-150 151-200**	\$169 \$406	per day fee (0 to 8 hrs = 1 Day) per day fee (0 to 8 hrs = 1 Day)
<p><b>Notes:</b>                      *Every hour above limit is charged an additional \$100 per hour.                      **Over 200 people are charged \$100 per every 100 people.                      Non-profit organizations must submit proof of federal tax-exempt status.</p>
